#### Award Process

Dollar amounts awarded vary from year to year based on the number of applicants and funds available. **No program will be entirely funded by Challenger Learning Center of Northwest Indiana.** Award notifications will be made via email in first week of August 2025. Please do not call Challenger Learning Center of Northwest Indiana by phone prior to this date to inquire about the status of your award.

#### I understand the following requirements if I do receive teacher grant funds:

1. I may be required to have my students complete a survey regarding their experience within 30 days after completion of the program(s).

2. I will be required to have my students send ONE COMBINED class thank you note to Challenger Learning Center of Northwest Indiana within 30 days after completion of the programs unless otherwise notified. Failure to do so may make applicant ineligible to receive further grant funding from the Challenger-Columbia Grant Fund.
